### **Guidelines on the packaging** of the PDO Parmigiano Reggiano

24 July 2012

With effect from 29 August 2012, following the entry into force of Regulation (EU) No. 794/2011<sup>1</sup> the packaging of the cheese bearing the PDO Parmigiano Reggiano shall be regulated as specified below <sup>2</sup>.

'Cheese bearing the PDO Parmigiano Reggiano' means:

- the wheel certified to be complying with the PDO Parmigiano Reggiano specification;
- the portions of a wheel that has been certified to be complying with the PDO Parmigiano Reggiano specification, that are not less than eights of a wheel and bear, even partially but clearly visible, the wording 'Parmigiano Reggiano' in pin dots <sup>3</sup> and one of the following distinctive signs: the oval stamp 'Parmigiano Reggiano Consorzio Tutela' <sup>4</sup>, the oval stamp 'Parmigiano Reggiano Export' or the oval stamp 'Parmigiano Reggiano Extra' 5;
- pre-packaged portioned cheese, certified to be complying with the PDO Parmigiano Reggiano specification;
- pre-packaged grated cheese, certified to be complying with the PDO Parmigiano Reggiano specification.

#### 1. Grating, portioning and packaging operations in the area of origin

Grating, portioning and packaging operations of the cheese bearing the PDO Parmigiano Reggiano must take place within the area of origin <sup>6</sup> <sup>7</sup>, and the verification of compliance with these requirements must be carried out by the control body <sup>8</sup>, before placing the pre-packaged product bearing the name Parmigiano Reggiano on the market.

#### 2. Operations allowed also outside the area of origin

(i) Retailers

Based on the principles expressed by the Court of Justice <sup>9</sup> of the European Union, at the retail stage, grating and portioning operations must in principle be performed in front of the consumer, or at least the consumer can require that it is, in order to verify in particular that the whole cheese used bears the mark of origin. Therefore, grating, portioning and packaging operations of the cheese bearing the PDO Parmigiano Reggiano, can be performed by retailers for sale to the consumer in the retail outlet where these operations take place, even if established outside the area of origin, at the buyer's request or also for immediate sale 10. Indeed, there is no difference at the retail stage between the product packaged (or 'wrapped') at the buyer's request and the pre-packaged (or 'pre-wrapped') product for immediate sale, since the consumer is always entitled to request, in particular in case of any doubt on the authenticity of the pre-packaged (or 'prewrapped') product for immediate sale, that grating, portioning and packaging operations be performed in his/her presence.

(ii) Mass caterer<sup>11</sup>

Grating and portioning operations of the cheese bearing the PDO Parmigiano Reggiano can be performed by mass caterers, even if established outside the area of origin.

The above principles expressed by the Court of Justice apply, in fact, to both retailers and mass caterers.

#### 3. The collective figurative trademark 'Parmigiano Reggiano and wedge and wheel'

The cheese bearing the PDO Parmigiano Reggiano, placed on the market pre-packaged, shall bear the collective figurative trademark 'Parmigiano Reggiano and wedge and wheel', to be reproduced in accordance with the technical conditions defined by the Consorzio through a specific agreement with the operator <sup>12</sup>.



In accordance with the product specification, this agreement may be signed only by operators with plants located in the area of origin, subject to the PDO Parmigiano Reggiano control system<sup>13</sup>.
